

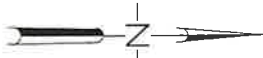

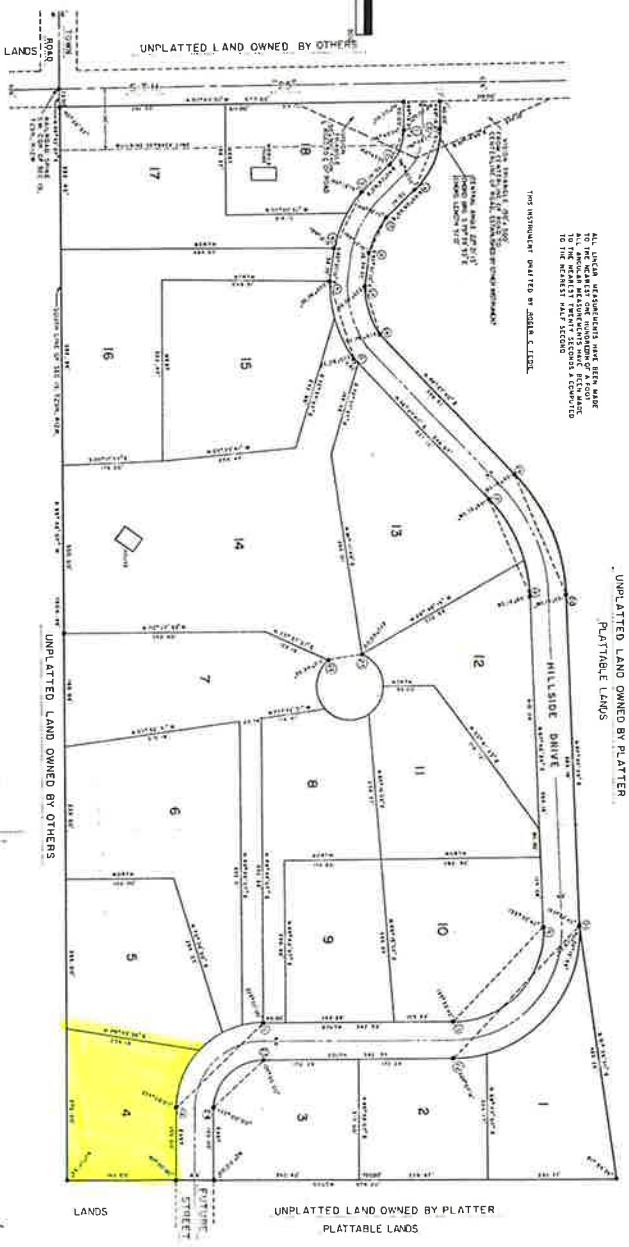
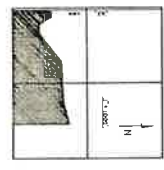

OWNER'S CERTIFICATE OF DESIGNATION

AS OWNERS, WE HEREBY CERTIFY THAT WE CAUSED THE LAND DESCRIBED IN THIS PLAT TO BE SURVEYED, DIVIDED, ADJUSTED AND DEDICATED AS REPRESENTED ON THE PLAT. WE ALSO CERTIFY THAT THIS PLAT IS REQUIRED BY S. 236.10 OR S. 236.12 TO BE SUBMITTED TO THE FOLLOWING FOR APPROVAL OR OBJECTION:

3. DEPARTMENT OF LOCAL AFFAIRS AND DEVELOPMENT
4. DIVISION OF HEALTH, DEPARTMENT OF HEALTH AND SOCIAL SERVICES

AS OWNERS WE HEREBY RESTRICT ALL LOTS AND BLOCKS, AND ALL ADDITIONAL LOTS WITHIN SECTION 19, TOWNSHIP 29 NORTH, RANGE 12 WEST IN TOWN OF DUNK, WISCONSIN, TO BE USED ONLY FOR RESIDENTIAL PURPOSES. WE HEREBY CERTIFY THAT WE HAVE NO OTHER PERSONS WHO WILL HAVE ANY RIGHT OF DIRECT VEHICULAR ACCESS OR ACCESS WITH STATE TRUNK HIGHWAY "H" AS SHOWN ON THE PLAT, OTHER THAN ONE ADDITIONAL PUBLIC ACCESS POINT TO BE LOCATED IN THE NORTHWEST 1/4 OF SAID SECTION 19. IT BEING EXPRESSLY INTENDED THAT THIS RESTRICTION SHALL CONSTITUTE A RESTRICTION FOR THE REVEAL OF THE PUBLIC ACCORDING TO SECTION 236.293, WISCONSIN STATUTES, AND SHALL BE ENFORCEABLE BY THE STATE HIGHWAY COMMISSION.
